Billing Information:

Non-member Information:

Non-Members may only use the pool during the scheduled lesson with the instructor.

Cancellation Policy:

Cancellation cut off date for group swim lessons is the Friday prior to the beginning of the session. **You will be responsible for payment if cancellation is not made by the cancellation cut-off date.** Make up class will be made up only for classes canceled by the **instructor or weather.** If a group lesson falls on a holiday, class will be rescheduled. Private lessons **must be canceled 24 hours** in advance. You will be responsible for payment if you do not follow proper procedure for canceling the lesson. To cancel call the LRRC Swim Lesson Coordinator or your instructor.

Weather Policy:

Class will be canceled if it is lightning 15 minutes prior to class. If schools are let out due to inclement weather, swim class will be canceled. If it is only raining we will have class.

Sickness:

If children have a rash, fever, or cold, please do not bring them to class as it exposes the instructor and other students.

Parent's Responsibility:

Arrive a few minutes early so we may start lesson promptly and your child will not feel rushed. Children must be picked up immediately after lesson, as the instructor will not be able to supervise children after class. Parents are asked not to be on pool deck during lesson. If you must remain on deck, please sit as far away from lesson as possible. This will allow your child to give full attention to the instructor.

Refund Policy:

We are unable to offer refunds for any reason. We can offer a 6 month swim lesson voucher which can be redeemed at any time during the next 6 months when space is available.
